Implementation date of FHA Payment **Supplement looming**

On 2/21/2024 the U.S. Department of Housing and Urban Development (HUD) announced the details of their new Payment Supplement option for FHA loans. The 30-page mortgagee letter puts servicers on notice that provisions of the ML must be implemented by 01/01/2025. Federal Housing Commissioner Julia Gordon said in the press release, "FHA developed this innovative tool because after interest rates rose the FHA Recovery Modification could no longer reliably provide payment reduction to borrowers facing a hardship." The Payment Supplement combines a Partial Claim along with a new "MoRP" or Monthly Principal Reduction. This will temporarily reduce the borrower's monthly mortgage payment for

a period of three years, without requiring the mortgage to be modified. After the Payment Supplement Period ends, the borrower will be responsible for resuming payment of the full monthly principal and interest (P&I) amount.

With a 01/01/2025 implementation date looming, servicers now face the overwhelming task of tearing up their well-planned release calendars to find where they can squeeze in this work.
